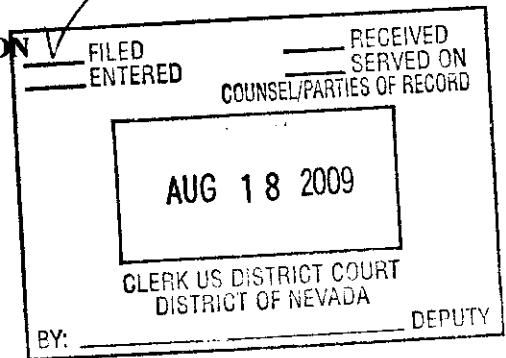

COMPLAINT FOR INJUNCTIVE RELIEF

This is an action under the Freedom of Information Act, 5 U.S.C. § 552 (2007) ("FOIA"), for injunctive and other appropriate relief seeking the disclosure and release of agency records improperly withheld from plaintiff by defendant Charles F. Bolden, Administrator of the National Aeronautics and Space Administration.
