This Court is not divested with jurisdiction to issue a Writ of Execution. Mack-Manley v. Manley, 122 Nev. 849, 855, 138 P.3d 525 (2006) and Foster v. Dingwall, 126 Nev. Ad. Op. 5, 228 P.3d 453 (2010).
