3 as undeliverable at any point in time.



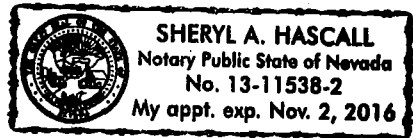
